5. Request for Advisory Opinion

First Selectman, Mr. Fortuna requests advisory opinion on whether having a town employee, Mr. Larry Bonin, install a Bilco door at his house complies with the Old Saybrook Code of Ethics. Mr. Fortuna also states in his request, "I do not want any appearance of impropriety or hint of favoritism in this transaction."

Discussion: Commission reviewed Sections 23-3A (conflicts of interest) and 23-5A and B (gifts, prohibited gifts, prohibited sources).

Commission reached consensus that based on Mr. Fortuna's letter, under the Code of Ethics, the potential transaction *could* create the appearance of a conflict of interest, even if one is not there.

Motion: Provide opinion that based on Mr. Fortuna's letter, where he does not want any appearance of impropriety or hint of favoritism, the transaction could create the appearance of a conflict of interest under 23-3a, even if one is not there. Cassella/Ladd **Approved**
