A. "Dunkin Donuts at the Shops at Oyster River" Request for modification of Special Exception approval for color change to discontinued Hardie plank siding 2,254 s.f. drive-through restaurant

Owners/Applicants: 923 Boston Post Road, LLC Agent: James McMahon, General Contractor

Jim McMahon, from Koffee House Corp, General contractors presented on behalf of this application. There was a lengthy discussion on why the materials were to be changed from Hardie Plank honey wheat to Hardie Plank honey glaze. J McMahon stated that he had waited too long to order the materials and in-process the original selection had been discontinued. There was a discussion related to Hardie reproducing the originally proposed honey wheat product however this would not occur until September 2019 which would create a delay in the opening of Dunkin' Donuts.
