II. OLD BUSINESS

 A. "CT Cancer Foundation" Application for Certificate of Zoning Compliance for Signs
15 North Main Street, Map 40/Lot 6 Shopping Center Business B-2 District Applicant/Agent: Sabrina Foulke Owner: CF 15 N. Main Street, LLC

At the April 10, 2017 Architectural Review Board meeting the Board moved to table this proposal with the request that the applicant look into replacing the proposed aluminum plinth with a stone material that is durable, solid and attractive. The applicant has requested a continuance of this proposal to the May 8, 2017 ARB meeting.

III. NEW BUSINESS

 A. "Ocean Art Studio" Application for Certificate of Zoning Compliance for Signs 188 Main Street, Map 37/Lot 130 Central Business B-1 District *Applicant: Deborah S. Rutan Owner: Coulter Street, LLC* Deborah Rutan who presented on behalf of this application stated that she is seeking approval for the installation of a $2^{\circ} \ge 8^{\circ}$ wall sign with lights, attached to the building and for the approval of lettering on four of the window panes on the left side of the doors. The existing footprint for the wall sign will be utilized.

A Brodeur commented on the "OceanArt Studio" wall sign on which there is a fish superimposed over the word "Studio". A Brodeur suggested that the applicant simplify the design of the fish so the word "Studio" is more prevlant.

E Grochowski suggested the inversion of the proposed sign colors so that the background is blue and the lettering to be white.

D Rutan stated that she will change the words imposed on the first written window pane from "Your Own", to read "Make Your Own"

MOTION to recommend approval of "Ocean Art Studio" Application Certificate of Zoning Compliance for Signs; 188 Main Street, Map 37/Lot 130, Gateway Business B-1 District with the following recommendations; 1) The sign colors will be inverted making the background dark blue and the lettering will be white; 2) The Fish silhouette will be cleaned up and simplified so as to make the word "Studio" more legible; 3) The size of the window lettering should be the same size for all four panes and the first window pane is to read "Make Your Own"; MADE by T Pendleton; SECONDED by A Brodeur; APPROVED by A Brodeur, T Pendleton, D Leake, E Grochowski; OPPOSED: None; ABSTAINING: None; (4-0-0)

 B. "Walmart" Modification to Special Exception Permit for Signs and Façade Renovation.
665 Boston Post Road, Map 36 Lot 103 Shopping Center Business B-2 District Applicant / Agent: Aisha Parker Owner: Old Saybrook Associates

Andrew Maass, Vice President, LEED Green Associates who presented on behalf of this proposal stated that the Walmart chain is in-process of rebranding their stores to reflect a new color scheme of grey with blue backing. At the Old Saybrook location the façade is currently painted in various shades of grey which will be re-painted in the color, Repose Grey P134, and the entry will be painted in Dorian Grey P135, and the sign will be painted in a "Walmart Blue". The brick will not be painted. A. Maass stated that the size of the sign and the lighting will not change.

Members stated that they prefer the blue Walmart "badge" sign on the rear elevation to be painted in the Dorian Grey P135 color.

MOTION to recommend approval of "Walmart" Modification to Special Exception Permit for Signs and Façade Renovation; 665 Boston Post Road, Map 36/Lot 103, Shopping Center Business B-2 with the following recommendation: 1) On the rear elevation, referenced as "#3a" on page one of the drawings, the blue façade will be changed to the Dorian Grey P135 color making that façade all the same Dorian Grey color; MADE by A
