S Missel called the meeting to order at 7:02 p.m. S Missel stated that she reserves the right to change the order of the agenda.

#### II. NEW BUSINESS

B. "Town of Old Saybrook" Application for Certificate of Zoning Compliance for Signs 155 College Street Extension, Map24/Lot 42 Saybrook Point SP-1 District

At the July 24, 2017 ARB meeting, Commission members reviewed the sign options and requested that the applicant provide further sign variations. The criteria set forth for the signs at the July 24th meeting included blue background, white letters, white directional arrows, white lighthouse logo, with blue posts.

Presenting at this evening's meeting was Liz Swenson, Economic Development Commission. L. Swenson stated that the Town of Old Saybrook has historically been considered to be an interesting, fun and engaging destination and the EDC is looking to create signage that would be inviting and respectful of people's interests.

A brief discussion on branding and uniformity ensued and L Swenson stated that presenting signs to the public that are readable and easily accessible is key. The EDC has looked at different sign designs and one that stands out against the environment was done in green

background with orange boader and white lettering. I. Swenson distributed photos of similar signage with this color scheme that is currently used in the City of New Haven.

L Swenson commented on the benefit of incorporating directional signage and consistency in signs across the town. L Swenson stated that she net with the sign designer and discussed the proposed sign colors and she noted that they would like to incorporate some color that would be fun and engaging, i.e., a gold banding and bordening around the frame of the sign that would work with the blue background with white lettering.

The general consensus within the Commission was to incorporate the two posts and the Lighthouse logo v the Town crest was unanimously preferred.

- S Missel referenced the proposed sign with the yellow/gold tone directional arrows noting that this was her preference. S Missel stated that she would like to see color samples.
- L Swenson stated that she would obtain color samples from the sign company and present a few different choices to the Commission at the August 28, 2017 ARB meeting.
- A Brodeur stated that an evaluation should be done of the existing signs in-Town signs that are done with a blue background and white lettering and he suggested that this proposal attempt consistency with those existing Town signs.
- S Beckman will glean photos of the three existing signs and have available at the August 28, 2017 ARB meeting. A Brodeur asked for a drawing in which it is reflected that the recurring signs on the kiosk have their own border which would distinguish each sign.

D Giastko stated that the existing sign will remain intact and a second proposed sign, 15' in height x 59.5" in width will be installed on a 5" sign board with a vinyl logo. There is no new lighting proposed on the building sign or on the street sign. The roof sign will be utilized as a platform and a new sign will be placed over it.

S Missel suggested that the red tea kettle which is situated on the existing Tea Kettle sign to be done in the same color of green which will be utilized on the proposed sign.
