#### 5. Set Mill Rate – Finance Director

Ms. Palladino passed out to the board an "Analysis of 2021 Grand List" 2022-2023 General Fund Budget.

She explained the calculations of adjustment in assessment due to potential tax loss. She went on to explain the 2022-23 revenue summary and Mill Rate calculation.

A motion by Mr. O'Brien to approve a mill rate of 20.08 for the fiscal year 2022-23 based upon a tax levy of \$46,604,698 and the Grand List of October 2021, was seconded by Mr. Swan and was so VOTED unanimously.

## 7. Tax Collector Suspense Report

Ms. Rzasa presented the Suspense Report, which is a list of outstanding tax accounts to be reclassified from active status to "suspended" for Grand List year 2016. This process is required for the annual audit review of tax collector records.

Mr. Bonin presented the board with a compilation of "Road Work" from the present back to 2001-02. Mr. Stevenson had several questions about equipment, old equipment for auction and other road issues.
