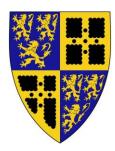

MEETING OF THE BOARD OF SELECTMEN

Tuesday, January 8, 2019 3:30 P.M.

Town Hall – First Floor Conference Room MINUTES

PRESENT: First Selectman Carl P. Fortuna Jr., Selectman Scott Giegerich, Selectman Carol Conklin and members of the public

- I. CALL TO ORDER- First Selectman Fortuna called the meeting to order at 3:30 PM
- II. PLEDGE OF ALLEGIANCE-Recited
- III. COMMENTS FROM THE PUBLIC-Tedd Levy expressed concern about the Eversource tree cutting plan and suggested that they agree to plant a certain amount of trees for every tree they take down; or that they contribute to the town's ability to purchase trees. The First Selectman informed Mr. Levy that Eversource and their contractor will be at the Planning Commission meeting next Wednesday.
- IV. COMMENTS FROM THE SELECTMAN: The Eversource 2019 Map and Tree Work Program was shared with the Board; 145 College Street- Dock n Dine property: the First Selectman sent the owner a letter asking him to at least make the property look a little better. If he has no plans to build, perhaps he should consider a sale.
