- III. COMMENTS FROM THE PUBLIC None
- IV. COMMENTS FROM THE SELECTMEN: Matt Pugliese asked about the support union contract, which is still being reviewed for final edits. He also wished everyone Happy Easter. Mr. Fortuna gave an update on Kate ticket sales, office remodeling in Town Hall, Phase II grant money received (\$500k), he spoke of bills of concern on firefighter cancer and MIRA, mentioned that he is attempting to get a few EV chargers in the pickle ball parking lot and mentioned the passing of John Ellis.
- V. APPROVAL OF MINUTES: Board of Selectmen Meeting March 22, 2022. FORTUNA /PUGLIESE MOTION CARRIED UNANIMOUSLY
- VI. BUSINESS BEFORE THE BOARD
  - **A.** Greetings to Ms. President USA Old Saybrook. This will occur at the next meeting.
  - **B.** Presentation by Robert Friedmann, Chairman, Zoning Commission, "Opting Out of Accessory Dwelling Unit".

Mr. Friedmann spoke to the opt out and the resolution passed by Zoning. His concerns were that there would be no zoning review of accessory dwelling units (ADU), just administrative review. He stated that Old Saybrook has adopted its own regulations preferring owner occupied which protects hotels and bed and breakfasts. He fears in Old Saybrook that opting in would lead to a tremendous amount of short-term rentals. He feels that our regulation assists the lower end rental market. He spoke to the maximum size of the ADU is bigger in Old Saybrook than in the proposed bill and that we are promoting more long-term rentals. While Old Saybrook ADU's don't count towards affordable housing percentages, they do promote affordability. Matt Pugliese requested additional time to consider the vote, which was granted. This matter will be on the next Board of Selectmen agenda.

**C.** Discussion and possible action on Deferred Compensation Investment Policy Statement for the management of the Town's 457b and 401a plans.

Lee Ann Palladino discussed. The policy speaks to the duties and responsibilities of the Pension and Employee Benefits Board, investment advisor and names the custodian of the funds. The policy discusses investment option monitoring, and investment policy review. Moved and approved.

D. Discussion and possible action on a provision for repeal of Section 209-10 of the Ferry Road Waterfront Regulations and recommend to town meeting. Bob Murphy and Paul Connolly are seeking repeal of this section of the town code. Allowing for seasonal dockage on the face of the main dock, not currently allowed, would provide 2-4 additional slips at Ferry Road. The Harbor Management Commission sees no reason for this section of the code to remain. Moved and approved to go to town meeting.
