C. Emergency Preparedness Novel Coronavirus:

Scott Martinson from CRAHD and Chief Spera, Director of Emergency Management, were present. Mr. Martinson commented on the expected duration (April 30) and the recent protocols that have been put in place with regard to gatherings, nursing home visitations and school restrictions. If there is a case, investigation will be key. Chief Spera discussed the recent meeting of the public health safety team and indicated that for now, Emergency Management is supporting Public Health. He discussed the protective mask shortage that is currently existing. The Governor has declared a Statewide Public Health Emergency which gives his extensive powers. Emergency Management can provide a call center if necessary. Superintendent Perruccio commented on the possibility of distance learning if necessary but this is a complicated issue. Internships in the medical field have ended. The issue of hot meals for children if school is suspended came up. Meals may be delivered by the OSPD.
