**E.** Discussion of the Connecticut Coalition for Sustainable Materials Management (CCSMM).

Mr. Fortuna outlined the goals of the CCSMM – Extended Producer Responsibility (EPR), Organics, Unit Based Pricing and Recycling. The Commissioner of DEEP started this group in light of rising cost of disposing of trash and the concurrent closure of the waste-toenergy facility in Hartford. The group met for six months and had over 70 towns partake. There was widespread agreement that significant legislative action needs to be taken, from state investment and permitting of organics disposal, modernizing the bottle bill, possibly implementing regional pay as you throw programs, EPR programs for propane containers, tires and perhaps Board of Selectmen Minutes January 12, 2021

> packaging. Our local task force is interested in better organics disposal and recently met with Blue Earth composting to get a price for this to take place at the town's transfer station. CCSMM encouraged elected officials and those who support better waste management to contact local legislators. There will be more updates as the legislative session starts.
