- I. CALL TO ORDER** – all members present

- III. COMMENTS FROM THE PUBLIC** - none
- IV. COMMENTS FROM THE SELECTMEN** - Matt Pugliese commented that he thought the unconscious bias training was interesting and thanked the First Selectman for organizing. The First Selectman commented on the following:
 1. towns recouping lost revenue
 2. marijuana legislation – It certainly looks as if marijuana will be legalized. If so, there could be proposals to make certain that stores are located in certain areas of town and not in other areas (like Main Street). Heather McNeil may come before the Board of Selectmen to discuss.
 3. climate initiatives/gas tax – The Governor is proposing a climate initiative that will raise the price of gasoline. It is a bit of a cap and trade but the argument is that it is environmentally friendly and will help fund transportation projects.
 4. new food fliers – Based on the work of the Waste and Recycling Task Force, flyers to encourage food scrap recycling will be handed out at the Transfer Station and distributed in other channels.
 5. bathroom locations from STEAP award - we have received permission to locate our composting toilets at Main Street Park and at Town Park. A bathroom at Saybrook Point will be reconstructed at the old pit toilet.
 6. Memorial Day parade – The First Selectman was hopeful that the town could have some sort of Memorial Day parade.

- E. Preliminary Discussion of an amendment of Chapter 128 of the Old Saybrook Town Code, Flood Plain Management-Proposed Amendments by Smoke on the Water at Dock & Dine/The Point, LLC.

Geoff Jacobson, the town's consulting engineer, gave a brief history of the flood program at the federal level and the history of this site noting that any new structure would have to be 14 feet in the air. He did note that in a flood area such as this, manufactured homes and recreational vehicles are allowed for 180 days. The current proposal is for a full service restaurant with trailers on wheels, not stationary containers. Mr. Jacobson had to leave the meeting. Attorney Cassella then presented noting that a zoning text amendment would be the first order of business followed by a special exception permit followed by a flood ordinance amendment. He has met with emergency management and noted that the capacity for this the former restaurant was 469 and this proposal is for about 300 seats. He noted that it would be bike and pedestrian friendly. The trailers would be temporary, not residential structures. New London had done something similar recently. The trailers can only be there for 180 days and must be highway ready. There must be an emergency plan and be able to be moved if a storm watch is issued. The town has to know the chain of command, routes of evacuation, cell phone numbers for chain of command, etc. The zone exception would be Saybrook Point 2, north of College Street. It was noted that the Economic Development Commission voted in favor. Mr. Giegerich stated that as it stands now, this is an exciting development. The timeline is March for the text change, April for the Special Exception and May for the change to the flood ordinance.

VII. COMMENTS FROM THE SELECTMEN - Prior to adjournment, Mr. Pugliese noted that a Shuttered Venues Relief Bill would allow for a second round of PPP assistance.
