- **I. CALL TO ORDER** First Selectman called the meeting to order at 3:30 p.m. All members present.
- II. PLEDGE OF ALLEGIANCE Recited
- **III. COMMENTS FROM THE PUBLIC** Chris Santasiero and his daughter commented on how disappointed they are in the paving job on their road at Rock Ridge. They feel the road is worse than what it was and that it is really bad for skateboarding and bicycling for children.
- **COMMENTS FROM THE SELECTMEN** Scott Giegerich mentioned that IV. he volunteered at the vaccination clinic a few times and that it is an excellent operation. Matt Pugliese commented encouraging businesses to reach out to the Economic Development Commission/Chamber for small business advice, particularly on loans; he is pleased to see food scrap recycling taking place at the transfer station. The First Selectman responded by discussing the strategy for ramping this up and lastly mentioned that Sustainable CT has some seminars on racial equity. The First Selectman commented on the following: All employees 20 hours and over will undergo unconscious bias training in March, the vaccination clinics are going well and getting great feedback; OS Cares continues to receive applications and take in donor funds; year to date expenses and revenues are tracking favorably; the Architectural Review Board design excellence awards were held last night and went very well. All recipients were very gracious in their acceptance and lastly, simply for discussion, the First Selectman discussed budget/referendum timing with the Governor's Executive Orders expiring April 20. Will the town go to referendum without absentee ballots or will the Board of Finance have to approve this year's budget again.
