CALL TO ORDER- All members present. Will Hochholzer and Carl P. Fortuna, Jr. Susan Esty from the Preserve ad hoc committee and Kathy Connolly.

- I. COMMENTS FROM THE PUBLIC- Kathy Connolly and Susan Esty attended. Kathy Connolly commented on the following:
 - 1. How much is in the TPL (Trust for Public Land) fund from monies raised? She indicated that she spoke with Honor Lawler several months ago but has not heard back since. Mr. Fortuna indicated he would reach out. Ms. Connolly also suggested that perhaps some of the state stewardship funds could be used for the Ingham Hill Road Trailhead parking lot.
 - 2. She resubmitted a letter from December 18, 2017 from the Preserve ad hoc committee concerned about what has not been accomplished from the list on that letter
 - 3. She is concerned about a bike jump and would like the State to look into what could be done to dismantle it.
 - 4. She is concerned about ATV's in the forest
 - 5. Standpipes from the proposed development still exist. It was suggested that it be determined if these are all located that we hire a contractor to come in and cut them off and cap them.
 - 6. Stilt grass- Ms. Connolly had good success with one particular area simply by cutting it.
