MINUTES OF SPECIAL TOWN MEETING - March 26, 2019

MINUTES of Special Town Meeting held March 26, 2019, 7:00 p.m. in the Old Saybrook Town Hall first floor conference room, 302 Main Street with approximately 15 persons attending.

Carol Conklin, Selectman, called the meeting to order and led the Pledge of Allegiance. On a motion duly made and seconded, it was unanimously voted that Jerry Labriola serve as Moderator for this meeting. The Moderator called on Sarah V. Becker, Town Clerk, to read the call of the meeting.

ITEM 1. To recommend to Town Meeting, based upon the recommendation of the Board of Selectmen and Board of Finance, an appropriation of \$126,000 from the Capital Non-Recurring account for repairs and reconstruction of the Katharine Hepburn Cultural Arts Center pedestal and pillars. Further said funds will be moved to an off budget account that will be entitled "KHCAC PILLAR REPAIR". On a motion duly made and seconded it was unanimously voted to discuss ITEM 1.

First Selectman Fortuna spoke regarding this request and noted that the "Kate" is a town owned building and we are responsible for this structure which is nearing its 10 year anniversary. Selectman Fortuna introduced Amy Jagaczewski, engineer responsible for this project, and she explained in detail the work that is required, process and scope of the project.

Following discussion it was duly moved and seconded and unanimously voted to ADOPT ITEM 1.

ITEM 2. To amend Chapter 118, "FEES", OF THE TOWN CODE TO ADD A THIRD ARTICLE ENTITLED "FEES FOR THE SERVICES OF THE OLD SAYBROOK FIRE MARSHAL:

The Moderator called on Michael Cronin, Town Counsel, to address the reason for this new commercial fee schedule. This schedule does not affect residential. He explained the role of the Fire Marshal and noted that it is a very busy office given the requirements/details of the job. If voted in the affirmative this schedule will take effect 15 days after the Town Clerk publishes in a local newspaper. The Moderator asked for any discussion and Eleanor LaPlace commented that we may be doing a disservice to our business community by enacting this fee schedule. On a motion duly made and seconded, it was unanimously voted to ADOPT Item 2.
