The members discussed a variety of items. Mr. O'Nell wants to focus on what this task force can do and do well. Mr. Fortuna reminded the board that there is a budget for the task force and other funds can be accessed from the nips funding. Food scraps from the transfer station were discussed and how the most effective way to get rid of food scraps is to mix with leaf mulch. The COG is seeking a pilot locally for this. Barry asked for metrics on food scraps: How much per week, savings? Perhaps the public could be better inspired to compost like this if they knew what difference they were making. The biochar facility was discussed. We will do a tour in the fall. Batteries were discussed and how better we can recycle. Perhaps we should have a bin at the Saybrook Hardware/ Walmart/Stop&Shop. Mr. Fortuna said he would speak with Melissa Lewis about transfer station fees and how they are broken out (tires, brush/metals). Mr. Therrien talked about getting back to his public access show. Mr. Fortuna gave a brief update on the transfer station re-design. Another idea that was discussed was plastic film recycling. Perhaps this can be done in conjunction with the schools and have a receptacle at Town Hall. Diane attended an Old Lyme meeting where Kim O'Rourke from Middletown spoke.
