MEETING MINUTES

March 12, 2020 2nd Floor Conference Room, Old Saybrook Town Hall 7:00 pm

I. CALL TO ORDER

The Chairman Matthew Pugliese called the meeting to order at 7:06pm.

V. STAFF REPORT

Economic Development Director Susie Beckman distributed the staff report. S. Beckman gave an update on discussions with Joe Commerford of 9Town Transit and the possibility of bringing trolley transportation to town. State DOT is relatively supportive. 9Town can make a capital request of the State, which would require the town to commit to a yearly contribution. There's also the possibility of 9Town leasing an older trolley and have Old Saybrook pay the operating costs. S. Beckman will continue discussions with 9Town Transit. M. Pugliese proposed sending a letter of support for the trolley to the Board of Finance for their meeting next week. S. Beckman is to draft a letter and circulate to members for comment.

S. Beckman reported that a meeting date of June 4 has been set with David Lehman, Commissioner of the Connecticut Department of Economic and Community Development (DECD), to share what EDC is doing and to have a round table discussion with other local businesses.

B. Correspondence & Announcements
