- Referral from Zoning Commission re: Off-Site Parking Petition to Amend Zoning Regulations "Off-Site Parking" Petition to Amend the Old Saybrook Zoning Regulations

After discussing the petition, the zones affected, commissioners discussed the Town's need to support the efforts of developers and businesses to redevelop property, attract new businesses and grow existing operations. Commissioners determined the petition would allow the Zoning Commission an appropriate level of control while providing the ability to grant a special exception under the proper conditions.

VI. OLD BUSINESS

A. Pathway Lighting – Following-up on the company's inquiry regarding moving the light pole at the end of Elm Street Ext, S. Beckman had talked with the First Selectman about the concern and updated the EDC. She will send an email to Pathway Lighting with an update.

VII. ADVISORY GROUP REPORTS

A. ED Plan of Conservation & Development (PoCD) Update – M. Pugliese shared that the Economic Development Strategy Group presented information at a joint EDC/Planning Commission meeting and received feedback on the presentation, ideas for inclusion in the ED Update of the PoCD and audiences to target with an improved presentation for input to the ED update

B. Mariner's Way Redevelopment – S. Roberts and S. Beckman shared that the proposed TIF Master Plan has been moving through the adoption process with the guidance of consultant Patrick McMahon, Executive Director of the CT Main Street Center. P. McMahon attended the Public Hearing set by the Board of Selectmen to review the proposed TIF Master Plan and answer all questions. Twenty people attended the Public Hearing. The next step will be a Town Meeting to vote on the proposed TIF Master Plan. A date has not yet been set.

C. Marketing Plan – S. Beckman introduced the concept of Married on Main to the Commissioners. Married on Main is an effort by a coalition of local businesses to make Old Saybrook a wedding destination and provide most, if not all, the complementary goods and services associated with a wedding in Old Saybrook. The coalition has requested that the EDC be the sponsoring agency of the effort and that the ED Office be the point for responding to email inquiries that come through the Married on Main website. The coalition will raise its own funds and has asked if the Town could hold an account for it. Discussion of the request proceeded. The commissioners though the idea had merit, but did not believe the EDC should be a sponsor of the effort and that the ED Director is a part-time position with numerous demands already, that the relationship of the ED Office with such a coalition should be similar to that with other business organizations such as the Chamber of Commerce, and that for the Town to house the account may not be legal, and even if it were it is inappropriate and brings of questions of what other organizations would want a similar benefit.

E. Arts & Culture

1. Art Hallway

The Old Saybrook Rotary Club is willing to partner with the EDC to accept a contribution from Eversource and purchase the hanging system for the hallway. S. Beckman will work with the OS Rotary Club to submit the grant application which will be due in June, 2019.

2. Cultural Arts Program – MOVE!

A small group of local artists are working on second program for March 2019 called MOVE! which incorporates dance/movement, visual arts, poetry and music into a cultural arts program.
