## **MEETING MINUTES**

March 11, 2021 7:00 pm Videoconference

#### I. CALL TO ORDER

Acting Chair, Elizabeth Swenson, called the meeting to order at 7:14pm.

## V. **STAFF REPORT**

- S. Beckman highlighted the following:
  - The Paycheck Protection Program (PPP) was expanded and application deadline is March 31.
  - The Emergency Injury Disaster Loans (EIDL) will be open to all businesses through the end of the year.
  - The February newsletter had a higher open rate than previous months.
  - Funding for Geofencing and Facebook ads were used to promote the Chamber of Commerce's Chili Week, resulting in increased impressions, views and visits to Main Street
  - DEEP announced a permit concierge service to expedite permitting.
  - It was determined after meeting with Amtrak representatives that it is not possible for the Town to gain public access to the CT River near the Amtrak railroad bridge, due to engineering and geographic reasons

A. Approval of Minutes: February 11, 2021

  - a. Referral: "Theater Marquee Sign" Petition to Amend the Old Saybrook Zoning Regulations

Text amendment to define 'marquis'

b. Referral: "The Kate" Application for Special Exception Use

Vice Chair Carol Conklin assumed the role of Chair. S. Beckman explained that the regulation changes would be specific to a theater sign; that the sign would be lit one hour before and after a show, and the lights would not move when the theater is dark. Members stated general support of both referrals. Members directed S. Beckman to send a letter of support to the Zoning Commission.

- S. Beckman discussed Acton Library's ten year plan, part of which is to do an architectural feasibility study, to reconfigure the space to meet the community's needs. Part of the reconfiguration will address co-working space. She is applying to the USDA for a rural business development grant, for the feasibility study. She asked that members review a drafted letter that is posted online and provide any comments or feedback. E. Swenson expressed support and added that a study room at the library would be beneficial.
- S. Beckman reminded members of the 2021 Housing Forum, hosted by the Land Use Department, on Tuesday March 30 at 6pm, via Zoom. All commissions are invited.

- C. Conklin inquired if marketing funds would be used for the Preserve, to promote outdoor activity.
- E. Swenson felt it was premature to promote to the public as the trails are not well-defined.
- D. Prendergast welcomed new members Barbara Labriola and Nick Prevost.

There was discussion about how best to show support for "Smoke on the Water." Members agreed that the newly appointed Chair should speak publicly at the meeting on behalf of the EDC.
