I. CALL TO ORDER

Scierka gave a report of EDC's online media performance, noting that the two segments produced by Better Connecticut have been well-received and attracted over 100,000 views and interactions on social media, and will continue to be used in EDC's marketing efforts. Two video projects are nearing completion, one on Mariner's Way and the second on the Town, and are expected to be released by the end of January.

C. Conklin expressed that she would like the videos to be available to those not on social media or the internet and that perhaps the public could be invited to a viewing, or the videos could be displayed in public places.
