
A. Approval of Minutes: January 13, 2022

VII. OLD BUSINESS

- A. FY '22-'23 Budget The EDC was not required to make a presentation this year because it had no increase in its budget.
- B. New Signs at Exit 67 off ramp & Wayfinding around town S. Beckman provided a mock-up of the sign provided by One Look Sign Company. The quote for the sign is \$3,103.07. The EDC directed S. Beckman to talk with the First Selectman about finding funding to purchase and install the sign.

- B. ARPA K. Hand provided an update from the ARPA Committee. The committee is discussing broad categories of potential funding priorities including: Small Business and Workforce Development support; Economic Resilience; Health and Safety; and Infrastructure. The commissioners discussed some project ideas (S. Beckman will provide some written proposals to them via email next week) and posed questions about broadband.

E. Swenson asked about the status of the cannabis moratorium. S. Beckman will provide information to the commissioners via email including the Zoning Commission minutes from February 7, 2022 and the date of any upcoming public hearings on the matter.


