IV. GUEST - Rich Scierka - Marketing Update

Successful marketing over the past year included videos and social media. R. Scierka recommends additional videos on history, recreation, events and other topics. E. Swenson is the EDC representative to the The Preserve Ad Hoc committee and suggested it is important to mention but it may be too early to focus much on promoting it as a recreational component. Good social media momentum that we should continue to leverage and easy, less expensive options than a film crew will be researched so we can be more responsive to current events and produce videos more quickly. R. Scierka also recommended using Geo-Fencing as a business recruitment tool for targeting marketing messages to businesses. It's possible to identify locations such as start-up incubators or bio-tech/bio-med businesses or programs to target expanding businesses.

The keynote speaker was very good and spoke about branding destinations and communities.
