A. **Preservation Initiative- Historic Sign Restoration**

Barbara Harms updates the commission on the historic sign restoration project. The revised proposal from Canning has been accepted and a 25% initial deposit has been made in the amount of \$6,250. The commission has been told that the work will begin sometime in March or April and take 4-6 weeks

to complete. Funds are still needed in order to finish the second half of the restoration at a later date. The commission has just received a grant of \$500 by the Community Foundation of Middlesex County. People can still donate at the town hall and new avenues of fundraising were discussed including: Articles in the events magazine and the Harbor news, apply again in the fall for the Community Foundation of Middlesex County grant (can be applied for three years in a row), present a presentation to the Estuary Council when luncheons are held again.
