Certificate of Appropriateness as to Exterior Features 69 Cromwell Place (Map 32/Lot 56) Applicant: Robert Laurie, Owner

Certificate of Appropriateness—Addition of Accessory Building (detached garage) and Alteration of Principal Building (enclosed side entry, enclosed front portico, landing and steps, and replacement window)

60 North Cove Road (Map 31 /Lot 16)

Applicant: Paul & Kathy Connolly, owners

Applicant/Owner Kathy Connolly presented a photo of the existing home and described proposed changes including front and kitchen door porticos, a replacement window on the back of the house (not visible from the public street) two eyehole windows (consistent with Cape designs) and an unheated, 1.5 car detached garage. The porticos will be covered with cedar shakes, the new windows and doors will be Marion Universal which North Cove Construction has used in the past and all other materials will be similar to the existing materials.

There was a discussion about replacement window on the back of the house. W. Childress added that 60 North Cove Rd is a Non-contributing structure and is subject to looser standards than other homes in the Historic District.

Peters made a motion to **Approve the Certificate of Appropriateness—Addition of Accessory Building** (detached garage) and **Alteration of Principal Building** (enclosed side entry, enclosed front portico, landing and steps, and replacement window) 60 North Cove Road (Map 31 /Lot 16) as presented; **Seconded** by M. Kennedy; **In Favor**: W. Childress, M. Kennedy, R. Peters and J. Furman; OPPOSED by none; **Abstained**: by none; **APPROVED**: 4-0-0.
