COVID-19 Public Health Emergency – TOWN STATUS – ORANGE

The following Community Update is being provided to you from the Town of Old Saybrook Emergency Operations Center.

The intent of this document is to provide a summary of preparedness, response and other government activities.

Opening Remarks

Hello Old Saybrook!

It's been awhile since we have published a COVID-19 Community UPDATE.

We appreciate everything that everyone did over the summer to limit the community spread of COVID-19 in Old Saybrook. Thank You!

We are communicating with you now as circumstances are changing and we are receiving new information from the State Department of Public Health.

We will do our best to communicate information to you.

Public Safety & Community Information

- The Nation, State, and Town remain under Declared States of Emergency.
- The Town's Emergency Operations Center (EOC) remains operational.
- Over the past week there have been 17 new CONFIRMED residential cases of COVID-19 in OS
- Old Saybrook belongs to the Connecticut River Area Health District (CRAHD).
- This includes the Towns of Chester, Clinton, Deep River, Haddam, and Old Saybrook.
- There were also new CONFIRMED cases of COVID-19 in our District over the past week.
- These are the total reported Positive Residential Cases, since March, according to CRAHD:

- Chester - 19 Confirmed Cases
- Clinton - 107 Confirmed Cases
- Deep River - 31 Confirmed Cases
- Haddam - 65 Confirmed Cases
- Old Saybrook - 42 Confirmed Cases


These numbers DO NOT include any Positive Cases at Convalescent Facilities.

■ Old Saybrook is currently experiencing its highest COVID-19 positivity rate since March.

NEW State of Connecticut Community Rating System

- The State Department of Public Health has created a new Community Rating System.
- The system classifies towns and cities based on 1) population and 2) how many residents have tested positive for COVID-19 on a two week rolling average.
- Towns and cities that have increased positive COVID-19 cases are designated as YELLOW, ORANGE, or RED.
- The State will make these designations each Thursday at 5 PM.
- When a town or city is classified specific actions are taken.
- This new State rating system **does not** impact the status of our public schools.
- No matter what "color" a town or city is, a different rating scale is used by the ALL Superintendents of Schools to make decisions concerning in person learning activities.
- When a community is classified as YELLOW, ORANGE, or RED there are six (6) categories of activities that are reviewed. They are:
 - Department of Public Health Response
 - Individual Response (That's YOU!)
 - Community Response
 - Organized Group Activities
 - Pre K-12 Schools
 - Business & Sector Rules
- Here is the map of the State with the Yellow, Orange, and Red designations as of 5PM today

- The Superintendent makes the decision concerning On Campus / In Person Learning vs Distance Learning based on facts concerning positive COVID 19 Cases, Contact Tracing Reports, and Staff Availability.
- If there is a positive case of COVID-19 in one of our schools, it does not mean the entire school must close. Being in cohorts may allow for only one class or only one grade to be impacted.
- The Superintendent continues to collaborate with Regional Public Health and Town Emergency Management when making these decisions.
- Schools have not been the source of Community Spread.
- In fact our schools are one of the only places in our community that model, mandate, and enforce mask wearing and proper hygiene. If schools are open they are safe.

- The C.A.R.E.S. Working Group is raising money for Old Saybrook residents that have been negatively impacted by the COVID-19 Public Health Emergency.

- Your donated funds will help those struggling to afford the very basic of needs such as housing, food, utilities, childcare, and transportation.
- Over \$60,000 has been distributed to those in need so far.
- The Police Department's Shorts4Saybrook Fundraiser is complete, raising \$28,365.61!

Connecticut Halloween Guidance

The ongoing COVID-19 pandemic requires all of us to take steps to keep ourselves, our families, and our communities safe and healthy: wear our masks, wash our hands frequently, and maintain social distancing. As a result, we will need to celebrate many fall traditions differently this year, including Halloween. Traditional Halloween activities carry a high risk for spreading COVID-19, but we can reduce that risk significantly by organizing and participating in fun, lower or moderate risk alternatives. The holiday may look different this year, but the Connecticut Department of Public Health (CT DPH) believes we can still enjoy a happy (and healthy) Halloween.

The CT DPH recommends that everyone planning to participate in Halloween activities this year review the <u>guidance</u> recently issued by the Centers for Disease Control and Prevention (CDC). That guidance describes "lower" "moderate" and "higher" risk activities. DPH recommends that Connecticut residents avoid higher risk Halloween traditions and focus celebrations on the lower and moderate risk activities.

The ability to maintain social distancing and follow face covering rules is especially important when participating in Halloween activities. In addition, please refrain from leaving your home for any Halloween activity and do not pass out Halloween candy if you are ill or have traveled to one of the states listed on the Connecticut travel advisory between October 16th and October 30th (i.e. 14 days before Halloween). In this case you should be following the testing and self-quarantining guidelines, per Executive Order No. 9C. CDC guidance and safety tips are summarized below, along with additional considerations for restaurants and colleges and Universities.

TRICK-OR-TREATING


Recommendations for Halloween 2020

- Traditional trick-or-treating is a high risk activity. Instead, the CDC and CT
 DPH recommends participating in one-way trick-or-treating where goodie
 bags or a large bowl of candy are placed outside of your home for families to
 grab and go while continuing to social distance.
 - If you are preparing goodie bags, wash your hands with soap and water for at least 20 second before and after preparing the bags.
- For people who choose to hand out candy:
 - Before you answer the door, make sure your face covering is in place over your nose and mouth, wash or sanitize your hands before answering door.
 - o Remain six feet from the Trick-or-Treater.
 - Place the candy inside the child's bag for them instead of having them take it from the bowl themselves.
- Homes providing candy may set up hand sanitizer stations outside or parents/guardians can pack a travel bottle of their own.
- Parents/guardians should limit the number of homes their children visit.
- It is not recommended to trick-or-treat with people outside of your household.
- Remain six feet away from people outside your household at all times.
- All trick-or-treating participants should wear a mask or face covering while outside at all times.
 - A costume mask (such as for Halloween) is not a substitute for a cloth or surgical mask. A costume mask should not be used unless it is made of two or more layers of breathable fabric that covers the mouth and nose and does not leave gaps around the face.
 - Do not wear a costume mask over a protective cloth or surgical mask because it can be dangerous if the costume mask makes it hard to breathe. Instead, consider using a Halloween-themed cloth mask.
 - Do not wear a costume rubber mask over another face covering of any kind.
