#### IV. New Business

A. Petition to Amend the Old Saybrook Zoning Regulations for Animal Care Services as a Special Exception Use in the AA-1 District. Sect. 9 new definition of animal care services, new Sec. 22.2.2 Animal Care Services as Special Exception Use and 53 Special Standards.

Petitioner: Erik P. Anderson and Jenny L. Anderson Agent: Attorney Edward Cassella

Attorney Ed Cassella presented for the applicant. Mr. Cassella stated that in the current regulations there are no accommodations for pet care in the AA-1 zone.

P. Kay stated that she had reservations that the new regulations were so specific, using the railroad abutment clause, that only a few lots would be permitted to have pet care.

Mr. Cassella responded that there would be 4-5 properties that would be permitted to have pet care in the AA-1 zone under the new regulations.

M. Jouflas inquired if the railroad abutment clause was unique to this new regulation?

C. Costa stated that there are other regulations through the town that use the railroad abutment as a clause in the regulation.

P. Kay reported from IWWC that the Commission was looking at a disc golf course that was proposed for the town park on Schoolhouse Road. Ms. Kay stated that the IWWC is looking at the fine line between using the natural resources spaces and preservation.
