470 responses to the survey.

4 sections of the plan have been completed.

Chris would like to get the completed plan done by Aug 1, 2023. Reviewed timeline suggestions, so that other boards/commissions have enough time to review and comment. Suggested adding an additional section for supplemental planning to refer to the most recent plan for certain sections, such as Mariners Way and Scenic Roads and Affordable Housing. Members agree that the referencing makes sense. She would like to post the preposed sections in public areas for review and have a meeting in May where the public can comment during a workshop, and then schedule the public hearing.

Chris spoke about beach communities and smaller lots that are running into parking issues when new septic's are installed, residents are losing their parking. Suggested giving public works director authority to make new parking area in affected areas, to prevent people from parking on the roads.
