Town Planner Christine Nelson reported on the following: - the Coastal Resilience project is wrapping up, the budget is closed out, and the consultants will review their findings at the November 15 meeting of the Planning Commission

- MapGeo, a mapping software application used by the Land Use Department, has a feature called "Docs", which stores digital documents related to each property; the Department is making a capital request for this add-on

# IV. WORKSHOP

# Local Planning for Integrating and Increasing More Attainable Housing

Representatives of the Housing Committee of the Shoreline Basic Needs Task Force: Lauren Ashe, Executive Director, HOPE Partnership, and Dawn Parker, Project Manager, The Connection

Dawn Parker explained the origins of the Shoreline Basic Needs Task Force, which today is a Task Force with three action groups: Housing, Hunger, and Wages. Lauren Ashe explained the concept of ALICE, both an acronym (Asset Limited, Income Constrained, Employeed) and a representation of a vulnerable individual, and who earns 60% or lower of the area median income. In Old Saybrook, the median income is \$106,200 for a family of 4; 60% of the median is \$63,720.

D. Parker explained the benefits of doing a housing inventory, to determine the "buckets" or categories of existing housing, to know what the town's housing stock is, in order to know what types of development the town wishes to attract. She strongly advised the formation of a coalition of town members to talk about housing and affect change in the long term. D. Parker remarked that housing drives our economy, that the economic engine runs better when people live, work, shop, and volunteer in their community.

D. Parker and L. Ashe noted that the organization Partnership for Strong Communities is a valuable resource.

D. Parker discussed the Connecticut Housing Finance Authority, CHFA, which provides home-buying assistance and financing.

C. Nelson agreed that an updated Town Plan consider including an action item to create a Housing Coalition.
