(Conservation & Open Spaces & Water Resources Sections)

John Guskzowski presented an outline for the Conservation and Open Spaces section of the Plan of Conservation and Development (PoCD).

Discussion was around the pre-submitted topics below:

CONCERNS FOR THE NEXT DECADE

- Is there such a thing as enough open space?
- Flooding risks how can we mitigate, educate and to a degree regulate what is done within a flood zone.
- Sewage Treatment Plant avoidance
- Balancing the "race to green" with open space (solar / wind)
- Sea level rise & flooding
- Shovel ready projects availability
- Sea Level Rise
- Water Quality
- Shallowing of South Cove
- Increasing development and home sizes near sensitive areas
- Wastewater management
- Privatization of shore access
- Storm damage
- Increased sprawl/impervious surface/GHGs

GOALS AND HOPES

- How can we work to eliminate phragmite and bring our wetlands back.
- Raise the roads that consistently flood during a heavy storm or extreme high tide
- Leveraging UConn & the National Estuarine Designation in managing coastline resources
- Funding for shovel ready projects
- Incentive programs for the Town and its residents to take advantage of
- Equitable access to natural resources
- Partnership with the National Estuarine Research Reserve
- Purchase of additional property near beaches and river (Dock and Dine, beach properties) to promote public access
- Greenways, bikeways, and blueway trails and walking routes highlighting historical, conservation, and scenic locations
- Promotion of low-impact eco-tourism hiking, biking, non-motorized boating
- Prevent further encroachment by development on existing natural resources and open space

- Find ways to acquire and otherwise prevent development in important natural resource corridors
- Find ways to encourage green building techniques: (Reduce impervious surface; Enhance water filtration for stormwater runoff; Optimize for passive heating and cooling where possible; Reduce, directly or indirectly, reliance on SOVs)

KEY ELEMENTS FOR PROTECTION

- The area along Plum Bank, Saybrook Manor, Indian Town and Chalker Beach, erosion of the beaches will just continue.
- Coastline
- Wetlands
- Public Access to Water
- Water Supply
- Marshes
- Power supply solar, battery, micro-grids
- Primary wildlife habitat

Mr. Guskzowski laid out some next steps he will be taking to prepare a working draft of the Conservation and Open Spaces section of the Plan of Conservation and Development Those steps included: Summary of Policy Areas and draft language to review.

D. McCracken reported that the Regional Planning Committee of RiverCog presented their regional housing plan on January 24, 2022. The RiverCog plan has similar principles as the Old Saybrook housing plan, there should be no conflicts.
