Re: Park & Recreation Account Restructure

Date: June 5, 2020

The purpose of this memorandum is to recommend a new structure of accounts for the Park and Recreation ("P&R") department. This recommendation comes forth in part due to the transition of the banking relationship from Liberty Bank to Webster Bank and in part from an operational review of their account structure. The recommendations below will streamline the P&R operations and allow for clearer financial transparency of the various P&R business lines. In particular, the recommendation is to bring all of the expenses and revenues associated with the Vicky Duffy pavilion onto the General Fund ("GF") as of July 1, 2020. Further, if this recommendation is approved, the Vicky Duffy budget line item will go over budget and it is recommended to watch this line item throughout the fiscal year as it is not expected to go over budget by \$25 thousand. Below is a discussion and justification for this recommendation.

## Background

By ways of background the Town is in the process of transitioning its banking business from Liberty Bank to Webster Bank. As part of that exercise, all banking accounts were reviewed as well as the accounting for many of our funds. After reviewing the general ledger and banking account structure for the P&R department, three of the eight Funds will remain the same. Within the other five P&R Funds, the expense and revenue transactions for various business that presently go through more than one fund, will be directly accounted for in the appropriate fund thereby streamlining the process and allow for clearer financial transparency into the business lines. Two Funds will be closed. Below is the existing account structure.

After reviewing the financial business with the Director of Park and Recreation, it was decided to restructure the accounts as follows:

The only part of the Vicky Duffy recommendation that will affect the budget is the moving of the revenues and expenses that now run through the P&R exchange fund onto the GF. There are three options for the BoF to consider during FY21.

- The first is to watch the account and allow it to go over budget as long as it does not exceed \$25 thousand.
- The second is to make an appropriation to the account at the beginning of the next fiscal year.
- Finally, if the BoF does not want to monitor this budget line item, transaction will continue to go off budget accounts until the next budget session. The latter option is not preferable as we would like a clean transition with the banking project, but can be done if necessary.

Of all the options, the first is preferable. The Director of P&R estimates that between \$15 and \$20 thousand of expenses will be transferred from the off budget fund onto the GF. Likewise, revenues

of a similar amount will also be transferred to the GF. Further, it is recommended to begin this restructuring on July 1<sup>st</sup> so that the management of the bank accounts and the structure of the Park & Recreation account structure moves in tandem.

Finally, the P&R debit cards will be closed and the P&R will be issued new Pcards in its place so that the Town may benefit from all purchases made with this card.
