The Town of Old Saybrook is granting awards to qualifying projects under this program. Old Saybrook seeks to fund projects that make the best use for long-term recovery, investment, and results. Projects that exemplify innovation and resilience shall take priority.</p> <p>The ARPA Committee will make recommendations to the Board of Selectmen, who reserve the right to accept or reject any proposals as deemed in the best interest of the Town of Old Saybrook.</p>	
<p>Timeline and Reporting: Funds must be used only to cover costs incurred from March 3, 2021 to December 31, 2024. The period of performance will run until December 31, 2026 to allow for the completion of lengthy projects. Part of that plan is to renovate Clark Community Park into a Softball field, and full size soccer field/Lacrosse field, to engineer the field the cost is \$219,130.00 asking for 89,884.00 to support the engineering costs</p>
