Minutes

- I. Call to Order Chairperson D. Aldi DePaola called the meeting to order at 7:00pm.
- II. Attendance D. Aldi DePaola, M. Briscoe, S. Craft, P. Funck, M. Iadarola, M. Kennedy, J. Termine, T. Belmont/VNASC, K. Desantis/VNASC, and A. Merritt (Recording Clerk). Absent: E. Owen.

Audience of citizens: T.Belmont, informed the board that senior center attendance is variable, sometimes quite a few people, sometimes only a few, including blood pressure queries and other health related issues. Estuary stop-ins are starting to increase, including requests for dental referrals, skin irregularity questions, food bank and nutrition queries - which has created a need for a future talk about food resources and nutrition.
