Police Arrest 4, Seize a Loaded Handgun, and Narcotics After Local Car Dealership Prevents a \$100,000 Fraud

Senior Leadership at Shoreline Chrysler, Dodge, Jeep, located at 255 Middlesex Turnpike, Old Saybrook alerted Old Saybrook Police of a possible fraudulent transaction that might be taking place later in the afternoon on Friday. The initial investigation reviled that individuals posing as customers were using fraudulent government documents generated by stealing the identity of an out of state resident. The bogus customers left a cash deposit at the dealership and promised to return. When they did, Old Saybrook Police were waiting.

The criminal actors arrived back at the dealership in two different vehicles at two different times, with one group waiting for the other. At 1807 HRS, when all parties were at the Dealership, Old Saybrook Police converged, and despite the efforts of one to flee, police located, detained, and then arrested all criminal actors involved.

A loaded handgun with a high-capacity magazine, a large quantity of narcotics including methamphetamine, extasy, crack cocaine as well as documents linking the four to identity theft were located in their vehicles.

"We take our role to safeguard our customer's information very seriously", said Alex Castergini Jr, an owner of Shoreline CDJ, "We are here to be a part of the community which means we have a responsibility to help safeguard it". "When we noticed something was off, we immediately contacted the Old Saybrook Police", said Kobe Tremblay also an owner of the dealership, "The only thing that comes above our dedication to our customers is the safety of the community we are proud to be part of". Because of this incident, the two have pledged to sponsor a fraud/identity theft prevention seminar to be led by Law Enforcement in the beginning of 2023.

"We will not tolerate this type of criminal activity in Old Saybrook", said Michael A. Spera, Chief of Police for the Town of Old Saybrook, "This is a perfect example of a public/private partnership that helps safeguard our community".
