The Old Saybrook Office of Emergency Management
STRONGLY RECOMMENDS
that you **EVACUATE** your home **THIS AFTERNOON.**

Your Home is located in an area that will flood or
will become isolated from the rest of the Town.
This is the **ONLY Evacuation Notice** you will receive.

Your **FIRST** option is to seek shelter
NORTH of I-95 with family, friends, or in a hotel.

Your **SECOND** option is to seek shelter
at the Town Evacuation Center.

The Evacuation Center is located at the
Old Saybrook Senior High School - 1111 Boston Post Road.
The Center will open at 7 PM TODAY!

Bring a three-day supply of clothes, medicine, and personal hygiene
products (MASKS) as well as a pillow and blanket.

Dogs and Cats are allowed at the shelter on first come first serve basis.
They will be kenneled in a separate part of the shelter
you may not have access to them, but they will be safe!
