C. "Sal's Pizza" Application for Minor Modification of Special Exception Permit

Request to construct a roof over an existing concrete patio and installation of a concrete patio in the front.

29 Spencer Plain Road, Assessor's Map 25/24-1, Gateway Bus. B-4 District, Ped. Node Owner: Bella Vita, LLC Applicant/Agent: Robert Mangino, Architect

Robert Mangino, architect, presented. They would like to cover a paved patio with a roof at the rear of the building. The structure will be open on three sides. The roof will not exceed 500 square feet. They will also be constructing a concrete patio in front of the building. The plantings

that will be removed to do so will be replaced with plantings in ceramic pots along the patio. There will be a fence around the patio as well as bollards no more than five feet apart.

MOTION to approve "Sal's Pizza" Application for Minor Modification of Special Exception

Permit to construct a roof over an existing concrete patio in the rear and installation of a concrete patio in the front at 29 Spencer Plain Road, Assessor's Map 25/24-1, Gateway Bus. B-4 District, Ped. Node with these conditions: Roof must be under 500 square feet with no side walls and that includes any type of temporary walls such as a tent; the bases of the light poles will need to be mounted flush and the poles must not exceed 14 feet in height; the front patio must include at minimum six planter pots to replace removed plantings; and lastly, a fence around the front patio with bollards not more than five feet apart. The applicant will provide updated information with including modifications. **MADE**: R. Friedmann

- Affordable housing with the intent to increase the number of small and affordable units at more than one income level.
