IV. OLD BUSINESS

A. Workshop: Cannabis

Old Saybrook has in the past approved two locations for a medical dispensary but neither site received a license. Moving forward, the Commission discussed possible options to be presented in a public hearing. Option A would be to prohibit all licenses. Option B would be to regulate what will be allowed and only in the B-4 and I districts. They talked about the various licenses available by the state: medical dispensary, cultivator/micro-cultivator, retailer, food & beverage manufacturer/packager and delivery service. They determined that they would prohibit outdoor growing. Thinking down the road, they discussed whether they would allow Marijuana to be sold in pharmacies if licensed by the FDA. M. Hunnewell and R. Hansen stated via zoom that they would like to apply for licenses and offered their expertise, as they own facilities in Massachusetts.

C. Workshop: Discuss Problematic Regulations & Possible Fixes

C. Costa, ZEO, presented possible text amendments to merge all drive-through standards into one set of special standards under section 53 to remove repetition. The Commission also discussed goods and services allowed through a pharmacy's drive-thru window besides prescriptions. L. Goergen, via Zoom, would like the Commission to review regulations regarding Breweries.

ZEO will have ADU opt-out text and marijuana text available at the next meeting on February 7, 2022. Also, Max's Place referrals are coming in.
