REGULAR MEETING MINUTES HYBRID MEETING

Monday October 2, 2023 – 7:00 P.M. Town Hall, 1st Floor Conference Room 302 Main Street, Old Saybrook

I. CALL TO ORDER

Chairman M. Caldarella called the meeting to order at 7:00 P.M.

III. REGULAR BUSINESS

A. MINUTES

IV. OLD BUSINESS

A. WORKSHOP: Drive-through windows as an accessory use for financial institutions, pharmacies, indoor restaurants or other food and beverage establishments (Section 53). *Moratorium ends: December 31*, 2023

The Commission discussed the draft text and what they felt were important factors to consider, including frontage, separation distance between businesses, access lanes, 2nd entrances and stacking of cars. R. Friedman stated that the major concern to address is public health and safety by not having cars back up onto Route 1 or any other major road. He used Burger King as an example of a restaurant drive-through that works well. The Chairman asked that the members review the draft text and send their comments to the ZEO to compile for their next discussion. The hearing to extend the moratorium to June 2024 is scheduled for October 16th.

V. COMMITTEE, REPRESENTATIVE & STAFF REPORTS

- Thanks to the work of Assistant Town Planner L. Wacker and S. Mackowicki Old Saybrook has obtained silver certification in Sustainable Ct which is a voluntary certification program that "recognizes thriving and resilient Connecticut municipalities."
- C. Costa discussed with the Commission the memo dated August 24th from the ZBA regarding rooftop decks and balconies. The ZBA would like the Commission to consider allowing them as a design feature. A concern the Commission discussed was that a roof top deck could infringe on the neighbor's privacy. The response from the Commission is that they would like to keep the regulation that is in place but perhaps tighten up the definitions through clarifications. The Commission will review the regulation and draft a response to the ZBA.
